## **EXECUTIVE DIRECTOR REPORT**

Director Bartlett pointed out that she had previously circulated the report. The only item she wanted to address was that they are watching budgetary costs go up due to contract rents increasing throughout Bergn County, causing to overspend HAP budget by over 1.2 Million. This is fine because of the amount in reserves and because the HABC has been designated an MTW agency. Also, an increase in admin fees will offset these costs.

Lastly, Director Barlett reported that Esther Gatria, Human Resources Director, has resigned and will be leaving the Housing Authority. Director Bartlett wanted to thank her for her 13 years of service and wish her the best of luck in all future endeavors.

As there were no comments or questions, nothing further was added or discussed.
